- (ii) subdivided (a) each of the authorised but unissued ordinary shares of HK\$0.10 each into 10 new ordinary shares of HK\$0.01 each and (b) every authorised but unissued convertible preference shares of HK\$0.10 each into 10 new convertible preference shares of HK\$0.01 each.
