During the period from the granting of the IBC Disposal Mandate by the Shareholders on 10 March 2017 up to 31 March 2017, the Company disposed of an aggregate of 5,000,000 IBC A Shares pursuant to the IBC Disposal Mandate and the net proceeds arising from the disposal amounted to RMB82.15 million. As at 31 March 2017, the Company beneficially owned a total of 38,936,000 IBC A Shares.
