ANNOUNCEMENT

UNAUDITED CONTRACTED SALES AND PRELIMINARY SALES STATISTICS FROM JANUARY TO JUNE 2015

The board of directors (“**Board**”) of Yuexiu Property Company Limited (“**Company**”) is pleased to announce the unaudited contracted sales and preliminary sales statistics from January to June 2015 as follows:

CONTRACTED SALES FROM JANUARY TO JUNE 2015 (UNAUDITED)

In June 2015, the Company’s contracted sales (including contracted sales by joint venture projects) value amounted to approximately RMB3,336 million with contracted sales (including contracted sales by joint venture projects) GFA amounted to approximately 333,400 sq.m., representing year-on-year increases of 6% and 35% respectively.

Aggregate contracted sales (including contracted sales by joint venture projects) value of the Company for the period from January to June 2015 amounted to approximately RMB11,487 million, representing a year-on-year increase of 8%. The corresponding aggregate contracted sales (including contracted sales by joint venture projects) GFA amounted to approximately 1,089,600 sq.m., representing a year-on-year increase of 30%. The aggregate contracted sales (including contracted sales by joint venture projects) value accounted for approximately 46% of the 2015 sales target of RMB24.8 billion.

CONTRACTED SALES AND PRELIMINARY SALES FROM JANUARY TO JUNE 2015 (UNAUDITED)

If preliminary sales (the formal sales contracts that are expected to be entered into soon) were taken into account, value of contracted sales (including contracted sales by joint venture projects) and preliminary sales from January to June 2015 increased to approximately RMB12,469 million, and GFA of contracted sales (including contracted sales by joint venture projects) and preliminary sales increased to approximately 1,177,800 sq.m..

According to the Company's project launch schedule for 2015, the contracted sales performance for the period from January to June 2015 was in line with the expectation of the management.

The above-mentioned sales data are unaudited and are based on the summary of internal information of the Company, which may differ from figures to be disclosed in the audited or unaudited consolidated financial statements to be published by the Company on an annual or semi-annual basis due to various uncertainties during the process of collection and collating of such sales information.
