ANNOUNCEMENT

UNAUDITED SALES STATISTICS

AS AT 30 APRIL 2017

The board of directors (“**Board**”) of Yuexiu Property Company Limited (“**Company**”) is pleased to announce the unaudited sales statistics as at 30 April 2017 as follows:

CONTRACTED SALES IN APRIL 2017

In April 2017, the value of the Company’s contracted sales (including contracted sales by joint venture projects) amounted to approximately RMB3,843 million, representing a year-on-year increase of approximately 42%. The corresponding gross floor area (“**GFA**”) amounted to approximately 242,600 sq.m., representing a year-on-year increase of approximately 13%.

The value of the aggregate contracted sales (including contracted sales by joint venture projects) of the Company for the period from January to April 2017 (“**Accumulated Contracted Sales**”) amounted to approximately RMB12,858 million, representing a year-on-year increase of approximately 13%. The corresponding GFA of the Accumulated Contracted Sales amounted to approximately 794,600 sq.m., representing a year-on-year decrease of approximately 27%. The value of the Accumulated Contracted Sales accounted for approximately 39% of the 2017 contracted sales target of RMB33 billion.

OTHER UPDATE

As at 30 April 2017, the value of preliminary sales (the formal sales contracts that are expected to be entered into soon) (“**Preliminary Sales**”) is approximately RMB1,386 million, and the GFA of the Preliminary Sales is approximately 82,400 sq.m..

If the Preliminary Sales are aggregated with the Accumulated Contracted Sales, the total value of sales and the total corresponding GFA are approximately RMB14,244 million and approximately 877,000 sq.m., respectively.

The above-mentioned sales data are unaudited and are based on the summary of internal information of the Company, which may differ from the figures to be disclosed in the audited or unaudited financial statements to be published by the Company on an annual or semi-annual basis due to various uncertainties during the process of collection and collating of such sales information.
